The Role

The QA will oversees quality assurance and quality controls including supervision of personnel, internal auditing, and quality improvement activities. S/he will be reporting to the director of operations controls.

Responsibilities

- Plan the Project Quality Management System (PQMS) activities within the project.
- Manage and oversee project quality to ensure compliance to codes, standards, regulations, specifications, and QMS requirements.
- Leading and Providing mentorship and training for the QA/QC personnel of all disciplines (Structural, Architectural and MEP) to improve the awareness of quality control issues and ensure that all QA/QC requirements are implemented at site according to the project's specifications and standards.
- Managing and oversee the implementation of the QMS and ITP for inspection, documentation, and operations activities are strictly followed in execution of the project.
- Review all the document submittals related to the quality such as Quality plans, ITPs, Method Statements, Action plans.
- Identify and develop in coordination with the contractors solutions to correct inspections deficiencies.

- Engage the technical team to deliver high quality works through collaboration with site supervision team.
- Prepare regular analysis and reports to the project manager with recommendations for improvement and preventive measures
- Manage the site internal audits and external audit to the contractors, suppliers, labs, etc.
- Design and maintain a reporting system that constantly indicates the work performance, learned lessons and the actions of improvement to enhance the quality system
- Prepare the required site notices (non-conformance, Observation Notices, Site Instructions), and review the corrective action and preventive action taken by contractors.
- Chair and document the QA/QC site weekly meetings with the project`s contractor and subcontractors.
- Investigate and attain to the client`s reports regarding quality of work.
- Assist in reviewing and documenting the project closeout documents.
- Ensure all quality control documentation is compiled and completed for as-built hand over
- Assist coordination and documentation of the testing and commissioning of building systems as part of site closeout procedure.

Day-to-day routines

Communicate and receive directions from the operations controls director. Manage and Plan the Project Quality Management System (PQMS), to ensure compliance and QMS requirements.
